2. Rental period
The rental agreement starts on (date)
3. Rental price and payment
The rental price is € for the agreed rental period.
Payment must be made in advance by bank transfer or cash and no later than the start of the rental period.
Deposit: Renter must pay a deposit of €500 for 125cc, €750 for 125-700cc and €1000

Deposit: Renter must pay a deposit of €500 for 125cc, €750 for 125-700cc and €1000 for +700cc, which will be refunded after the end of the rental agreement, minus any damages or costs.

4. Use of the motorcycle

The motorcycle may only be driven by the renter or persons designated with the written permission of the owner.

The renter must be in possession of a valid driver's license.

The motorcycle may only be used for personal use and may not be sublet.

The renter must comply with all traffic regulations and legal obligations.

5. Insurance and liability

The renter is liable for all damage to the motorcycle that occurs during the rental period, unless this is caused by normal wear and tear.

In the event of damage, theft or loss, the renter must immediately inform the owner.

6. Maintenance and condition of the motorcycle

re renter declares that he has received the motorcycle in good condition. Any damage present on the vehicle before the start of the rental period is stated here:
The renter must always inform the owner of this and take photos of the damage already present.
The renter undertakes to return the motorcycle in the same condition, except for normal wear and tear.
Any malfunctions, damage or other problems must be reported to the owner immediately.

The renter is obliged to regularly check the oil level, tyres and other basic components

7. Fuel

during the rental period.

The motorcycle is delivered with a full tank and must be returned with a full tank.

If the motorcycle tank is not returned full, a flat rate of 30 euros will be charged for filling the tank.

8. Cancellation and early termination

The renter can cancel the agreement up to 14 days before the start date of the rental period. In the event of cancellation, the owner is entitled to charge 50% of the deposit.

The owner reserves the right to terminate the rental agreement prematurely if the renter does not comply with the terms of this agreement.

The owner reserves the right, due to force majeure or for any other reason, to cancel the motorcycle chosen by the renter or to offer an alternative.

9. Return of the motorcycle
The motorcycle must be returned no later than at to the following address:
If the motorcycle is not returned on time, an additional amount of €50 will be charged per half hour.
10. Final provisions
This agreement is subject to Spanish law.

All disputes arising from or related to this agreement will be submitted to the competent court in the district of Tenerife.
